Overview and Eligibility Information

- These courses are for individuals who need to gain initial certification in IYAS or IRAS. These courses <u>are not for recertification</u>. Please look for other opportunities from IJC for recertification.
- The IYAS training courses are designed for individuals who supervise youth and are required to be **certified users** of the IYAS.
- The IRAS training courses are designed for individual who supervise adult offenders and are required to be **certified users** of the IRAS.
- Eligible participants include: court-appointed probation officers, community correction officers, Court Alcohol & Drug program professional staff, Problem-Solving Court intake staff/case managers/coordinators, and parole agents.

Training and Registration Information

Training/Certification information:

- All trainings will be held at 30 South Meridian Street, Indianapolis, IN 46204.
- Training consists of two full days (Day 1 begins at 9 a.m.; Day 2 begins at 8:30 a.m.)
- All participants must be on time for both training days.
- All participants must successfully complete the training course and pass the certification test in order to use the IRAS/IYAS instruments and be granted access to the INcite application.
- Successfully completing the training course means full attendance and participation in course sessions and exercises.
- Course sessions and exercises are designed to provide participants with knowledge and understanding needed to properly score the assessment instruments.
- Certification test will be given in the afternoon of Day 2.
- Examination scores are kept confidential and if the participant fails the examination then the participant will be informed of the criteria they missed.
